Check the New Applicant box. A photograph is **NOT** required.

- 1. LAST NAME Self-explanatory
- 2. JR., ETC. Self-explanatory (Write N/A if not applicable)
- 3. FIRST NAME Self-explanatory
- 4. MIDDLE NAME Self-explanatory
- 5. PA PHOTO ID/DRIVER LICENSE NUMBER If available, enter the driver's license number. If you do not have a driver's license number you must possess a PA Photo ID available through the Drivers License Exam Center (781-8231).
- 6. STATE: Enter the state of issuance.
- 7. DATE OF BIRTH Enter date of birth in an eight-digit month/day/year format, e.g., 12/07/1965, 08/11/1966.
- 8. SOCIAL SECURITY NUMBER Optional, but will help prevent misidentification.
- 9. AGE Self-explanatory
- 10. SEX Enter the sex, i.e., F Female, M Male, or U Unknown.
- 11. RACE Enter the race, i.e., American Indian or Alaskan Native, Asian or Pacific Islander, Black, White, or Unknown.

- 12. HEIGHT Enter three-digit height in feet and inches, e.g., 5 foot, 8 inches as "508", six foot as "600".
- 13. WEIGHT Enter a three-digit weight in pounds, e.g., 096, 185.
- 14. HAIR COLOR Enter the hair color, i.e., Bald, Black, Blond or Strawberry, Blue, Brown, Gray or Partially Gray, Green, Orange, Pink, Purple, Red or Auburn, Sandy, White, or Unknown or Completely Bald.
- 15. EYE COLOR Enter the eye color, i.e., Black, Blue, Brown, Gray, Green, Hazel, Maroon, Multicolored, Pink, or Unknown.
- 16. STREET ADDRESS Enter the street address of the residence. If the address is an RD number, e.g., RD1, Box 345, an actual street name shall also be required such as RD1 (Old Jonestown Road), Box 345.
- 17. CITY Self-explanatory
- 18. STATE Self-explanatory
- 19. ZIP CODE Self-explanatory
- 20. HOME TELEPHONE NO. Enter the area code and telephone number of the residence.
- 21. EMPLOYER/BUSINESS NAME Self-explanatory
- 22. WORK TELEPHONE NO. Self-explanatory
- 23. OCCUPATION Self-explanatory
- 24. ADDRESS Enter the street address of the applicant's employer/business. If the address is RD number, e.g., RD1, Box 345, an actual street name shall also be required such as RD1 (Old Jonestown Road), Box 345.
- 25. CITY Self-explanatory
- 26. STATE Self-explanatory

- 27. ZIP CODE Self-explanatory
- 28. REASON FOR A LICENSE TO CARRY FIREARMS Check the appropriate box (es) to indicate reason for obtaining a License to Carry Firearms, i.e., Employment, Gun Collecting, Hunting & Fishing, Other, Self Defense, or Target Shooting. If other is checked, indicate the reason in the space provided. **NOTE: only one reason will be printed on your permit.
- 29. PLACE OF BIRTH Self-explanatory
- 30. TWO REFERENCES NOT FAMILY MEMBERS Enter the name, address and telephone number of two individuals who have known you for at least two years. Please provide phone numbers that are reachable during business hours, 8:30-4:00p.m.

The license is valid for five years unless sooner revoked. Please bring your driver's license with you for identification purposes.
