This notice is provided pursuant to PA Administrative Code Section 1905-A, as amended by Act 14, which requires a 30 day public comment period.
2. Arcadis U.S., Inc. (received April 12th) regarding Columbia Gas Transmission, LLC’ s intent to file apply to PA DEP for a Chapter 105 Waterway Engineering and Wetlands General Permit. The project name is “Line 4226 SR948 Road Crossing Casing Mitigation Project”. Project location is Highland Township. This notice is provided pursuant to PA Administrative Code Section 1905-A, as amended by Act 14, which requires a 30 day public comment period
